**1. Call to Order**

Chair Phillip Spenrath called the meeting to order at 11:08am am CDT. A roll call of the planning group members was taken to record attendance and a quorum was established prior to calling the meeting to order.

**2. Welcome**

Chair Phillip Spenrath welcomed members to the meeting.

**3. Approval of minutes from the previous meeting**

The draft meeting minutes were reviewed, and corrections were made on the titles of agenda items 3 and 5 for consistency.

Kelly Payne moved to approve the minutes as amended, seconded by Kacey Paul.

The motion passed by a vote of 5-0.

#### **4. Public comments (Public comments limited to 3 minutes per speaker)**

Chair Phillip Spenrath opened the floor to public comments.

Lauren Graber said that written comments from Mieko Mahi were submitted to Region 10 via email prior to the meeting regarding Hallettsville and Lavaca County flooding concerns. Lauren recommended Mieko Mahi also consider submitting her comments to the full RFPG at the upcoming meeting in which the group would take public comment for pre-planning purposes.

#### **5. Update, discussion, evaluation, and action concerning the technical consultant procurement for Region 10 Lower Colorado-Lavaca RFPG**

##### **a. Update, discussion, and evaluation of responses to the RFQ**

Lauren Graber described the RFQ process. The RFQ was posted on February 11 and closed on March 8 and the full RFPG previously delegated the review of the RFQ responses to the Executive Committee. She explained that Kelly Payne, although a member of the Executive Committee, did not submit scores due to his involvement as LCRA's sponsor for the RFQ. She outlined the evaluation criteria, which was based on four factors: firm experience; personnel experience; project approach; and exceptions to the draft contract terms and conditions. Responses to the RFQ were submitted by Halff Associates, Inc. and Scheibe Consulting, LLC. Each Executive Committee member who scored the responses verbally confirmed their total scores. Halff Associates, Inc. had the highest score with all four members. The Halff Associates, Inc. team includes Halff Associates, Inc. as prime, with HDR, Freese and Nichols, and Water PR as sub-consultants.

##### **b. Consideration of a recommendation to the full RFPG for the selection of a technical consultant to provide services in conjunction with the development of a regional flood plan for the Region 10 Lower Colorado-Lavaca RFPG**

Chair Phillip Spenrath asked if a member had a motion for a recommendation. Kacey Paul moved to recommend the highest-ranking firm, Halff Associates, Inc., to the full RFPG for selection; Kelly Payne seconded. The motion passed by a vote of 5-0.

#### **6. Public comments (Public comments limited to 3 minutes per speaker)**

Chair Phillip Spenrath opened the floor to public comments. No comments were given.

#### **7. Adjourn**

Kelly Payne made a motion to adjourn, seconded by Kacey Paul.

The motion passed by 5-0.
