Cris Parker with HDR provided updates, briefings, and discussion related to the results of Task 4B - Identification and Evaluation of Potential Flood Management Evaluations and Potentially Feasible Flood Management Strategies and Flood Mitigation Projects as follows:

Cris Parker reported on the detailed screening of potential FMPs, FMEs and FMSs with the TWDB flowchart and guidance, resulting in a reduction in the number of FMPs and a slight increase in the number of FMEs. On detailed review, no projects fit the FMS category, which requires a potential Strategy to quantify estimated flood risk and potential level of flood risk reduction.

The technical consultant suggested that the RFPG consider including regional "strategies" in the plan as thematic recommendations which do not require a sponsor or a cost. The committee discussed pros and cons of this suggestion and will continue consideration at the next Technical Committee meeting.

The team will continue refining the list to complete Task 4B and transition to Task 5. Cris Parker and Mike Personett reiterated that the team will reach out to communities and other governing bodies to add missing projects to the list and determine local interest in sponsorship.

Mieko Maki requested that the Committee remember flooding concerns in the Lavaca River basin when reviewing the potential FMPs, FMEs, and FMSs.
